Rhode Island is considered to be one of the most litigious states in the country. This means that there is a high likelihood that someday you will unexpectedly need an attorney. With the average fee of an attorney being approximately \$250.00 per hour, affording legal assistance can quickly become difficult, especially when two out of three legal issues are unexpected. (Your association membership provides for employment-related legal issues).

Since 1993, NEARI has offered a legal protection plan to help you deal with this potential problem. As a member, you will be protected against the high cost of legal assistance should the need arise. Additionally, the plan will give you peace of mind knowing you can contact an attorney simply for advice or for actual representation for a complex legal matter. Membership costs just pennies per day. With the new basic plan, which is available to new applicants only, an individual can join for around \$2.00 per week, or they can choose the more complete plan for around \$3.00 per week. (This program is for all non-employment related issues).
